Notes:

1. Only the authorized person in CIDB (PPK) or (SPKK) or UPKJ can attend the site visit and tender briefing session. The authorized person shall need to bring the said Certificate (Original Copy and Photocopy) for reference.

Where the authorized person is listed under CIDB, the tenderer shall comply with the tender registration requirements of CIDB (PPK), CIDB (SPKK) and PPK (STB) (if applicable).

Where the authorized person is listed under UPKJ, the tenderer shall comply with the tender registration requirements of UPKJ, UPKJ (Bumi) (if applicable) and CIDB (PPK).

2. The Tenderers shall not authorize officers other than authorized person in PPK or SPKK or UPKJ to attend the compulsory site briefing and site visit.

3. All expenses related to the participation in the compulsory site visit / tender briefing shall be borne by the Tenderers.

4. Tenderers shall make their own interpretations, deductions and conclusions from the information made available and shall accept full responsibility for such interpretations, deductions, and conclusions. Tenderer may at their own expense make additional site investigations of they so desire.

The Tenderer and any of the personnel or agents will be granted permission by the Government to enter upon the site for the purpose of such inspection or investigation, but only upon the express condition that the tenderer, his personnel or agents, will release and indemnify the Government and its personnel and agents from and against all liability in respect thereof and will be responsible from personal injury (whether fatal or otherwise), loss of or damage to property and any other loss, damages, costs and expense.
